This update once again gives you some bits of information that I have come across which I hope you may find useful as you look after your church buildings

Church Building Support Officer

I am pleased to inform you that our new Church Building Support Officer, Chris Young, started in the middle of February. Below Chris introduces himself

As the new Church Building Support Officer, I am looking forward to helping in the work of preserving so many beautiful places of worship. Each church I have visited in the first couple of weeks has its own unique characteristics and challenges. If I can help support these amazing spaces so they are more accessible for mission while respecting their heritage, then I know I will have made a positive difference for people in the diocese.

To give a background on what I bring to the job, I have worked initially in the civil service then as a museum professional for ten years at the leading museum in the Tees Valley. Last year I worked as both Exhibition Officer part time and as the Diocese Mission Pastoral Committee Secretary at Newcastle Diocese. This combination of experiences has helped me identify a cross section of skills I am looking to apply to the role. In my spare time I am working on a book on the arms and armour of the Spence Collection and I have a personal project to translate the Collectanea Satis Copiosa, one of the founding documents of the Anglican Church.

I don't get lots of spare time though, as I have a two year old who gobbles it up and a wife who would rightly judge me if I always had my head in a book.

Accessing Support from the Church Building Support Officer (CBSO)

To ensure that support from Chris is distributed fairly across the diocese, any parish wishing to access support will need to complete a simple application form which outlines the type of support that you would like for your building project. After the form is submitted, the support is reviewed by the Church Building Panel who will decide if the support can be offered to the parish. Church Building Grants

We are currently trying to put together an updated grants database to allow us to provide parishes with information on which grants they can apply for. Energy Footprint Tool for 2023 Energy Usage

The energy footprint tool (EFT) is now open for you to enter your 2023 energy date. The EFT is accessed via the parish returns website and guidance documents are available on the website.

We have currently had data entered from 10% of our churches and it would be great to reach at least 50% by the end of the month.

Cost of electricity supply upgrades

For parishes looking to connect to an electricity supply, or upgrade from single phase to three phase, the cost changes brought into force on 1st April 2023 through Ofgem's *Significant Code Review* can make a huge difference. The changes mean that while we still pay to connect to the electricity network, we no longer pay for improvements to the network (e.g. upgrading substations). The details are explained on the <u>National Grid's significant code review webpage</u>. If a quote for connection looks extremely high, it is a good idea to check that the parish is working from a quote obtained since 1 April 2023 – the difference could be tens of thousands of pounds.

Church Heating Systems

Over the last couple of months we have had a number of churches experiencing problems with their heating systems. In some cases this has been due to boiler issues but in some it is problems with the other parts of the heating system. We have our boilers serviced on a regular basis but how often do we get the rest of the heating system checked. A build up of sludge in our systems can prevent the effective flow of water around our systems and can block valves. This means that the heat that we are producing is not getting to all parts of the building and can not only put strain on the boilers and pumps but also result in much higher gas / oil usage. Whilst, it may not be necessary to have the whole system checked every year, it is something that needs to be carried out on a regular basis, perhaps every 4 or 5 years, particularly if the pipe system is old.

Oil Boilers

As part of the routemap to Net Zero Carbon the Church of England has stated that no new oil fired boilers should be installed from 2026 onwards. If you have an oil fired boiler, now is a good time to start exploring alternative options for heating your church so that you have a plan in place when the boiler eventually does need to be replaced.
